PUBLIC HEARING THE HANGAR BAR AND GRILL LIQUOR LICENSE

Chairman Burleson opened the public hearing for Lounge Retail Liquor license Class 1 requested by applicant, The Hangar Bar and Grill located at 100 Airport Road, Muscle Shoals. Chairman Burleson asked for anyone in support of the liquor license to speak. Owner Tommy Henry spoke in support of the license. Chairman Burleson asked a second time for anyone to speak for the license. No response. Chairman Burleson asked a third and final time for anyone else to speak for the license. No response. 6. Approved appointment of Mr. Ty McConnell to the North West Alabama Regional Airport Board.
7. Approved payment of accumulated annual leave in the amount of 560.64 as requested by Michael Kumse. His resignation was effective December 4, 2014.
8. Approved demotion from position of Chief Deputy to position of Deputy for Jim Berryman. This demotion is effective as of January 15, 2015 with an annual salary of 36,983.50. This request was made by Sheriff Ronnie May.
9. Approved demotion from position of Sheriff's Chief Clerk to position of Dispatcher for Maria Strickland. This demotion is effective as of January 15, 2015 with an annual salary of 27,827.47. This request was made by Sheriff Ronnie May.
