#### CONSENT AGENDA

Chairman Gardiner announced that the business before the Commission was the approval of the consent agenda. ## **REPORTS FROM STAFF**

Chairman Gardiner announced that the Commission would hear reports from staff. Upon being recognized by the Chair, the following reports were heard by the Commission:

### **County Administrator:**

Administrator Roger Creekmore made the following reports. There are 2 unanticipated vacancies on the Board of Equalization for the Revenue Commissioners office. Mr. Crochen Seal and Mr. Kyle Buchannan will no longer serve. The Code of Alabama allows for the 45-day, temporary appointment of board members, to be made by the Chairman of the County Commission. Chairman Gardiner has appointed Ms. Sharon Burns and Mr. Raymond Howard as 45-day, temporary Board of Equalization members. Creekmore relayed a request from the District Judge to consider July 5th as a holiday. Franklin County has done so. Commissioners added request as an agenda item. There was a request from the Boy Scouts at Camp Westmoreland asking the Commission if they would make an appropriation to defray cost of the roof replacement on the Ranger Building. Commissioners asked if Lauderdale County was also contributing. Chairman Gardiner instructed that the request be made an agenda item for the July 2 Commission meeting. The administrator reported that Wesley Gage Wear was hired, effective June 17th on the Litter Crew, part-time no benefits at \$12.00 /hr. pay rate. Tyler Pennington was terminated from his position on the part-time litter crew, effective June 10. Tonia Price was hired, effective June 12, at the Water Department, in the position of Water Clerk, part-time, at the rate of \$15.00/hr. no benefits. Amber Hodges was hired in the Probate Judge's office, effective June 17, in the position of Tag Clerk, at an annual rate of \$26,591.48.

#### **County CFO:**

CFO April Bearden requested suggested budget meetings to be held August 5, 6, 13, 26 and 27 with the regular meeting to be held on September 3<sup>rd</sup> if needed.

#### **County Attorney:**

None

#### E-911/EMA Director:

Director Jody Hitt reported that his first week as director started off with a wild ride. He explained the reason for the failure of the Storm Siren System to activate last week. The system was installed beginning in the late 90's will require attention with built-in fail-safe redundancies. An increased maintenance and replacement budget should be considered. Hitt said they are looking at a system that will be county wide and works through a satellite. Hitt is looking at revising S. O. P. and assign individuals / DNR. They will be checking the conditions of all sirens as well as looking into extra training.

#### **County Engineer:**

County Engineer Jeremy Robison reported as follow: Richard Kentrell was given the wrong pay scale. It should have been \$50,356.80, including 5% cost of living. Robison also reported that the paving contractor is covering a lot of ground with some of Commissioner Baley's District finished as well as Commissioner Bendall's District. They will soon start on Alloys and move west.

#### Comments by Other Elected Officials:

Sheriff Eric Balentine addressed the Commissioners and informed them of a F. A. T. machine being in use at the Shooting Range. This machine gives scenarios to help the officers determine how to deescalate various situations. They will be charged a discounted rate of \$25.00 per person, Sheriff Balentine invited the Commissioners attend and experience a part of what the officers do. Also, Balentine stated that he does not usually endorse products however, there is a "Hero Link" he has purchased for all of his officers. The Hero Link is a bracelet that stores your medical

information. Balentine said that if one of his deputies needed help, paramedics will have all of the deputy's information to medically assist them. He has already purchased 100 of them to ensure they all have one. The price is \$20.00 each for law enforcers and first responders. He stated that it would be nice for non-verbal elderly people to one to help save lives fast. The Sheriff wants to sponsor some "Hero Links" for the Leighton Community and is looking for ways to raise money to help purchase more.
