Minutes of a Regular Meeting of the Colbert County Commission 07/16/2024

The Colbert County Commission met today in regular session at the Colbert County Courthouse. Chairman Gardiner called the work session to order at 5:00 p.m. with the regular meeting following at 5:12 p.m., being the time and place previously scheduled for such work session and regular meeting. All Commissioners answered "present" at the call of the roll with the exception of Commissioner Isom who was absent. Chairman Gardiner offered the prayer and led the Pledge of Allegiance. Chairman Gardiner declared that a quorum was present for the purpose of the transaction of business.

PUBLIC COMMENTS

Karen Crowe, Colbert County Extension Coordinator addressed the Commission and informed them of Tomato Sandwich Day, Friday, July 26, 2024 at 11:00 A.M.

PUBLIC HEARING

Chairman Gardiner stated that the next order of business would be a public hearing on the application for SAMU INC / D.B.A. White Oak Liquor, for 011-Retail Liquor Class II Package, and gaveled the public hearing to order.

Chairman Gardiner made a call for any person wishing to speak against the issuance the license to address the Commission. Chairman Gardiner made 2 additional calls for any persons wishing to speak against the license to stand and be heard. No person came forward to speak against the license.

Chairman Gardiner made a call for any person wishing to speak in favor of the issuance of the license to address the Commission. Chairman Gardiner made 2 additional calls for any persons wishing to speak in favor of the license to stand and be heard. No person came forward to speak in favor of the license.

Chairman Gardiner then declared that the public hearing be closed.

Chairman Gardiner stated that the next item on the agenda was a Quasi-Judicial hearing on a Junk Ordinance Citation issued to April Liles, 6440 E. 2nd Street, Muscle Shoals, AL. The Chairman stated that this matter requires the Commission to conduct a quasi-judicial hearing, which means the body must find facts and base its decision on the competent, substantial, and material evidence received during this hearing. All testimony must be competent and not repetitious. Speculative opinions and general expressions do not constitute competent evidence.

The Chair stated that notice of the hearing had been properly served upon the property owner and received proof of same into the record.

The Chair then recognized Mr. Danny Allison, Nuisance Officer for Colbert County. Mr. Allison presented a compiled report detailing the nature of the violation and including pictures of the violation and a detailed list of action taken by him to persuade the property owner, Ms. April Liles to abate the Junk. Mr. Allison indicted that some, but not all, of the junk has been abated. The Chair stated that Mr. Allison's report would be received as evidence in the matter.

The Chair then asked if Ms. Liles was in attendance to speak on her own behalf, she was not in attendance. The Chair then invited any other party to speak on the matter before the board, there was none.

After discussion by Commissioners, Chairman Gardiner stated that the hearing would be continued until September 3, 2024.

Chairman Gardiner then declared that the hearing was hereby adjourned.

The Chairman stated that this matter requires the Commission to conduct a quasi-judicial hearing, which means the body must find facts and base its decision on the competent, substantial, and material evidence received during this hearing. All testimony must be competent and not repetitious. Speculative opinions and general expressions do not constitute competent evidence.

The Chair stated that notice of the hearing had been properly served upon the property owner and received proof of same into the record.

The Chair then recognized Mr. Keith Wyrick who addressed the Commission. Mr. Wyrick indicated that he was deaf and did not fully understand the reason for the violation. He further stated that his daughter who is mentally challenged lives at the address.

The Chair then invited any other party to speak on the matter before the board, there was none.

After discussion by Commissioners, Chairman Gardiner stated that the hearing would be continued until September 3, 2024.

Chairman Gardiner then declared that the hearing was hereby adjourned.

CONSENT AGENDA

Chairman Gardiner announced that the business before the Commission was the approval of the consent agenda. Commissioner Bailey made a motion to adopt and approve the matters placed on the consent agenda during the work session. The motion was duly seconded by Commissioner Barnes. Chairman Gardiner stated that the adoption and approval of a consent agenda comprised of the following items of business was properly before the Commission and stated the matters as follows:

- 1. Approved July 2, 2024, meeting minutes and waived reading of same.
- 2. Approved payment of July 16, 2024, bills as presented by the Chief Financial Officer.
- 3. Approved Funding Agreement between The Colbert County Commission and Colbert Animal Services for the expenditure of ARPA / Revenue Replacements funds in the amount of \$50,000.00 and adopted the following Resolution to authorize execution of the Agreement:

RESOLUTION NUMBER 2024-0037

A RESOLUTION AUTHORIZING THE AWARD OF PUBLIC FUNDS TO SUPPORT ANIMAL CONTROL OPERATIONS

WHEREAS, the County has received a Coronavirus State and Local Fiscal Recovery Fund ("SLFRF") award under the American Rescue Plan Act ("ARPA funds") from the U.S. Department of the Treasury which have been duly designated as revenue replacement funds; and

WHEREAS, the revenue replacement funds may be used for the purpose of providing government services, including investments in community engagement programs to promote healthier lifestyles for its citizens; and

WHEREAS, Colbert Animal Services has requested funds to provide veterinary services to animals confined in the shelter and pay spay and neuter expenses; and

WHEREAS, the Colbert County Commission has determined that providing funding to Colbert Animal Services to support this public purpose is a necessary, reasonable, and proportionate expenditure of the revenue replacement funds.

NOW THEREFORE, BE IT RESOLVED by the Colbert County Commission award up to the sum of Fifty Thousand and no/100 Dollars (\$50,000.00) to provide payment to reimburse Colbert Animal Services for expenses relating to the provision of veterinary services to animals confined in the shelter and to pay spay and neuter expenses as set forth in that certain Funding Agreement between Colbert County, Alabama and Colbert Animal Services.

BE IT FURTHER RESOLVED, that the Chair of the Colbert County Commission, be and he is hereby authorized to execute and deliver the Funding Agreement on behalf of Colbert County, Alabama.

- 4. Approved office reorganization plan for the Probate Office, as presented by Probate Judge Daniel Rosser, creating the positions of Assistant Probate Clerk (Grade 7) and Election Assistant (Grade 6).
- 5. Approved request from Jason Flannagan for payment of unused accrued annual leave to Raleigh Lemaster in the amount of \$1,177.94, to be paid out to his estate.
- 6. Approved Resolution to Award Bid for New EMA Building Roof Replacement to Mid America Roofing in the amount of \$98,423.00. Project to be done with CDBG-CV Funds.

BE IT FURTHER RESOLVED, that the Colbert County Commission does hereby authorize its Chairperson, Jimmy Gardiner, to sign contract documents with the abovementioned contractor for the completion of CDBG CV Project #CV-NC-20-022 for a contract amount of \$98,423.00.
