The Colbert County Commission met today in regular session at the Colbert County Courthouse. ## **REPORTS FROM STAFF**

Chairperson Bailey announced that the Commission would hear reports from staff. Upon being recognized by the Chair, the following reports were heard by the Commission:

#### County Administrator:

Administrator Roger Creekmore made the following reports: Appointment for representative on the DHR board will be on the agenda for June  $3^{rd}$ . Lee Cox currently holds this position. Kimbrough Automotive has completed repairs on all storm shelter generators. The Colbert County Community Development Committee has awarded a grant to the Cowboy Church in the amount of \$20,000.00 for construction of a safer places storm bunker. Russell Brooks has been hired to fill the vacant IT Manager position, start date of April 21 with a salary of \$52,137.54. Creekmore reported that there was a termination in the Sheriff's Dept. of Corrections Deputy David Gifford. Also, from the Sheriff's Dept., Carlos Stanfield, was hired effective April 17 as a full time Corrections Deputy with a starting salary of \$32,985.27; Luke Collier Truitt was hired as APOST Certified, CPR Certified Deputy, effective May 1 with a salary of \$38,007.77. There is newly hired Courthouse Security Deputy for the 2<sup>nd</sup> floor, former State Trooper Brett Bishop has accepted the contract position at a starting salary of \$35,904.00 effective May 1. Austin Hester was hired as a full time Correction Deputy effective May 1 at a starting salary of \$32,985.27. From the Household Garbage Department, Charles Johnson has been hired as an HHG helper, moving from Litter Crew, with a starting pay of \$14.31/hr.; Matthew Green has been hired as PT Litter Crew beginning April 25 at \$12.36/hr. A resignation from Justin Lambert was received from the Water Department effective May 7.

#### **County CFO:**

CFO April Eaton made the following reports: Mr. McPherson will have the financial statements ready within the coming weeks. The Department of Public Examiners will schedule our FY 24 audit as soon as financial statements are complete. A new bank account will be opened for the Sheriff's vehicle loan program. This account will be used to deposit budgeted funds for the annual loan payment and will be specifically used for said purpose.

#### **County Engineer:**

County Engineer Jeremy Robison made the following reports: Robison spoke with EMA Director Jody Hitt who is currently at a vehicle liquid fertilizer spill on North Pike Rd. at the bottom of Burt Goodloe Hill. A Road Dept. crew was sent to assist.

The Road Department has started summer mowing on both the East and West ends of the County and will start in the middle when time and personnel allows. Work continues on damage resulting from March storms, 3 roads were washed out in Commissioner Barnes District. One of the roads was worse than the others and has been closed the last 6 weeks for repairs. A bridge abutment was also washed out in which a contractor had to be called in. Robison stated that this storm is going to be expensive and unfortunately does not qualify for any FEMA reimbursements. He feels that expenses incurred could possibly reach \$150k. This past winter with all of the snow we had, pavement markers were removed by the motor graders. To replace the markers as well as get markers on roads that need them that didn't have them in the past, will cost around \$182K, to replace only the markers that were graded up, the cost will be around \$52K. Each marker costs \$6.
