Minutes of a Regular Meeting of the Colbert County Commission 08/26/2025

The Colbert County Commission met today in regular session at the Colbert County Courthouse. Chairman Bendall called the work session to order at 5:05 p.m. with the regular meeting following at 5:31 p.m., the time and place previously scheduled for such work session and regular meeting. All Commissioners answered "present" at the call of the roll. Tommy Barnes offered the invocation and led the Pledge of Allegiance. Chairperson Bendall declared that a quorum was present for the purpose of the transaction of business.

PUBLIC COMMENTS

Lisa Reburn began by reiterating that she was not there to speak about a dog. It is about her family, future family, neighbors, friends and community. At 8:30 July 22, her daughter-in-law, Katherine, had her 2 unleashed dogs out for a walk. She saw a red truck pull over on the side of the road and let out 2 growling German Shepards of which one charged her and her dogs. The German Shepard pinned and attacked the smallest dog. Katherine's Siberian Husky defended her all the while Katherine yelling at the owner of the German Shepard for him to help. The man did not help. His retreated dog jumped into the back of red truck. The man put a rope up and then drove off. Reburn discovered that we are unincorporated and have limited law enforcement and authority. But we do have some authority and some law at large and feel we need to use that.

The Sheriff and DA spoke with her, and the Sheriff has agreed to take this case to court which could result in a \$2 to \$50 fine for this long repeat offender in the community. She believes that the Judge could add some court fees but is not certain but feels that we could look at repeat offenders coming back through. Since the incident he has been warned by a Deputy Sargent and Lieutenant. The offender is fighting the summons and is still doing it. So, his actions don't show that he cares. Reburn says, we need to stop this. Reburn pointed out that there is Emily's Law, but it is interpreted by our legal leaders as basically about being reactive and unfortunately someone has to be seriously injured or killed for it to go into phase. This law has not been helpful.

Reburn handed out data sheet taken from the CDC's website showing dog attack fatalities in the U.S. and showing an accelerating trend. In addition, per-capita dog attack rates, 2018-2023 which shows Alabama as $2^{\text{\tiny nd}}$ in the country for dog attack fatalities.

Ms. Reburn is hoping that the Alabama Legislature will take positive action to address this issue and asks for the County Commission to support efforts for positive change.

Commissioner Bailey stated that they have discussed this issue at the Colbert Animal Services and invited Mrs. Reburn to attend and have an open discussion regarding this matter. The meetings are held every Friday at 9:00 A.M. at the Muscle Shoals City Hall.
